The Campaign Reporting Act, pursuant to N.C.G.S. §163-278.14, states no contribution may be made in the name of another individual, thus joint contributions may not be accepted or reported. It will be necessary for you to determine the amount of each individual contribution from each person for the entries highlighted on the enclosed copies of your Political Committee Disclosure Reports. This information should be retained with your accounting records. In addition, the Report needs to be amended to reflect the individual contributions. The amended Report needs to be filed with the Forsyth County Board of Elections and a copy also needs to be sent to the State Board of Elections.

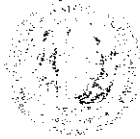

Thank you for promptly providing the information that was requested by the Forsyth County Board of Elections. Copies of the checks provided have been examined and a determination has been made that the contributions from the following contributors were either business contributions or personal contributions written on business accounts:

Business contributions of any kind are prohibited pursuant to N.C.G.S. §163-278.19. As a result, the contribution must either be returned immediately and the refund must be shown on the next disclosure report or the disclosure report on which the contribution is reported must be amended to include a notarized statement attesting that the contribution came from the personal funds of the contributor rather than the business funds. Violation of N.C.G.S. §163-278.19 is a Class 2 misdemeanor. Failure to take the required action will result in forwarding of the matter to the District Attorney of Forsyth County.
